

Please read these Promotion terms and conditions (“Terms and Conditions”) carefully. Participation in this Promotion will constitute your agreement to comply with these Terms and Conditions. If you do not agree with these Terms and Conditions, please do not participate in this Promotion.

1. The Promotion is named Zwartkops Air Show 2018 (“Promotion”). The promoter of the Promotion is WIRUlink (Proprietary) Limited, Registration number: 2006/011482/07 and/or its agencies (“the Organizer”).

2. Promotion Period: The Promotion will run for one day only, Saturday, 05th May 2018 (“the Promotion Period”).

2.1 The duration of the Promotion may be extended or curtailed at the discretion of the Organizer.

2.2 Any changes to the Promotion Period will be published on www.wiru.co.za

3. Who may enter: All participants must: (i) be citizens of the Republic of South Africa and/or a legal resident of the aforesaid country, (ii) be currently residing in the Republic of South Africa at the date of the commencement of the Promotion Period, (iii) be a natural person and be at least 18(eighteen) years old.

8.12 If part or all of any clause of these Terms and Conditions is illegal, invalid or unenforceable it will be read down to the extent necessary to ensure that it is not illegal, invalid or unenforceable, but if that is not possible it will be severed from these Terms and Conditions and the remaining provisions of these Terms and Conditions will continue to have full force and effect.
